Crown reduce and prune back to most recent growth points leaving furnishing growth and crown continuity, crown lift to 3 meters above public footpath to contain. Trees have grown out of control, prune to contain crown and root spread.

T1 Silver Birch (betula pendula)

Reduce crown height by up to 3 meters and prune to shape leaving furnishing growth for crown continuity as tree is growing out of shape.
