T3 = Large CHESTNUT - Remove all major deadwood formatively and selectively reduce laterals by 1-2m leaving internal growth to form a screen, lift to 5m over carriageway.

GRP1 - Medium mixed Vegetation/Shrubs encroaching onto footpath - Face back to boundary only to ensure free passage on Englands Lane footpath.

REAR garden

T4 = Large HAWTHORN (in adjacent garden of No.4) - Reduce lateral limbs that are encroaching on garden of No.3 by 2m and shape accordingly.
