ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at: 62 Greencroft Gardens, London, NW6 3LX as shown outlined in black on the attached plan ("the Property").

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission: *Demolition of a Victorian brick wall and installation of a timber fence*

4. **REASONS FOR ISSUING THIS NOTICE:**
 1. *It appears that the breach of planning control has occurred within the last 4 years.*
 2. *The loss of the Victorian brick front boundary wall has an adverse effect on the appearance of the character and visual amenity of the South Hampstead Conservation Area, contrary to policies A1 (Managing the impact of development), D1 (Design) and D2 (Heritage) of the Camden Local Plan (June 2017)*
 3. *The installation of a timber fence along the front boundary wall, by reason of its visual prominence is an incongruous addition, would*

harm the streetscene and the wider South Hampstead Conservation Area, contrary to policies A1 (Managing the impact of development), D1 (Design) and D2 (Heritage) of the Camden Local Plan (June 2017)

5. **WHAT YOU ARE REQUIRED TO DO**

Within a period of **three months** of the Notice taking effect:

- 1) *Completely remove the timber fence located on the front boundary wall of the property; and*
- 2) *Reinstate the front boundary brick wall to match the Victorian original as closely as possible in terms of height, materials and detailed execution; and*
- 3) *Make good any damage to the property as a result of the works.*

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **20th November 2017** unless an appeal is made against it beforehand.
