T1 - London Plane

Reduce back 1x lowest limb from rear elevation of the building to allow approximately 3 meters clearanc. Reduce back 1x lowest limb growing towards rear elevation of 28 - 30 Throebald Road, to previous reduction points by a reduction of up to approximately 3 meters of the branch length. Remove 1x lowest limb over hanging neighbouring roof to the rear of the rear boundary. Remove stub from lowest limb over hanging the rear of No.36 from previous pruning. Reduce 1x lowest limb over hanging the rear garden area of No.36 by approximately 4 meters of the branch length. Carry out climbing inspection to check for massaria. Remove deadwood.

- The tree is located in the garden area of Hult House to the rear boundary.
- Reduction and removal of limbs as per the specification of works to reduce the encroachment from the rear elevations of Hult House and adjacent neighbouring buildings.
- To reduce the encroachment from the roof areas of the neighbouring building rear of the rear boundary of Hult House.

- Carry out a Climbing Inspection to check for Massaria while there is a climber within the tree.
