The Council has considered your application and decided to grant permission

## Informative(s):

1 Condition 6 of permission 2015/6018/P requires full details of the external lighting proposed for the coal drops yard thereby approved. Full details as well as fixing information and specification has been submitted.

The Council has assessed the information and materials and in relation to design, details and specification and they are considered appropriate as they will not dominate the external look and feel of the buildings, are sympathetic to the general area and in line with the materials which are used on the existing building. The lights would have minimal back spill or back spill protection accessories to reduce light spillage.

The details submitted for condition 6 are considered sufficient to demonstrate that the proposed external lighting will be of high quality design and suitable for the site.

The site's planning history and relevant appeal decisions were taken into account when coming to this decision. The full impact of the proposed development has already been assessed. The details submitted have been assessed in relation to the approved scheme, the site and its surroundings.

As such, the proposed development is in general accordance with policies CS14, CS15 and CS17 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies as well as Policies C5, C6, D1, D2, A2 and A3 of Camden's Local Plan 2017.

2 You are advised that conditions 2 (Part), 4, and 11 of permission 2015/6018/P are outstanding and require details to be submitted and approved to the Local Planning Authority.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraphs 186 and 187 of the National Planning Policy Framework.
