Please describe the current use of the site:

The application site is a commercial building split across basement, ground and five upper storeys of which ground through fifth floor are used as office accommodation. The site has undergone recent renovation by Morgan Lovell to a Category A specification. The have access to a private roof terraces on street elevations whereas the terrace for the first floor is located on the south elevation of the building. The terrace is enclosed by Saffron House on the north, east and south elevations. The structure of Saffron House to the south of the terrace is a single story building and has a 1000mm gap with concrete plinths in place backing directly onto the rear of 30 Greville Street. The surrounding roof scape includes condensers for 30 Greville Street and 3, 4 & 5 Kirby Street.

The building is located at the southern end of Kirby Street and is close to both the Kirby Street/Greville Street and Saffron Hill/Greville Street junctions.
