Proposal: Minor amendments to Reserved Matters approval 2014/5272/P (granted 27/10/2014), as amended by 2016/2866/P (23/08/2016), relating to the Fish & Coal Offices and Eastern Wharf Road Arches and associated landscaping. The proposed amendments relate to the introduction of 7no cycle stands; 1 x lamp column; 2 x tree up-lights, Relocation of the proposed wayfinding sign and a change to the proposed species of tree and additional details of the works to the heritage wall as an amendment to reserved matters approval 2014/5272/P dated 27/10/2014 for refurbishment of the Fish and Coal Offices for office (Class B1a) and restaurant/public house (Class A3/A4) use and landscaping of the Coal Drops Ramp, part of the Coal Drops Yard and Wharf Road Viaduct, as required by conditions 6, 9, 10, 12, 14, 16-23, 26, 27, 28, 31, 32, 33-36, 45, 46, 49, 51, 55, 56, 60, 64-67 of outline planning permission reference 2004/2307/P granted 22/12/06 for a comprehensive, phased, mixed-use development of former railway lands within the Kings Cross Opportunity Area.
