Holly (T1) - Reduce height by 1.5m, trim sides and shape the crown to conical (not rounded).

Viburnum (T2) - Reduce the top by .5m, get a bit more clearance from the house. Shape the low section near the path. Try and maintain overall shape but make it a bit smaller.

Cherry (back wall) (T3) - Reduce crown by up to 2m, back to previous cuts. Remove any rubbing branches and dead wood.

Cherry (near house) (T4) - Reduce crown by up to 1m. Reduce the branch over the house to the height of the gutter. Reduce long branch over the neighbour's garden to uprights 1.5m from tips.
