ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at: 48 Mornington Terrace, London, NW1 7RT shown outlined in black on the attached plan ("the Property").

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission: The unauthorised erection of a black metal and glass outbuilding in the rear garden.

4. **REASONS FOR ISSUING THIS NOTICE:**

The development, by reason of its design, material, scale, bulk and location, has a detrimental impact on the character and appearance of the Camden Town conservation area, on the appearance and setting of the host grade II listed building and on the setting of the wider terrace of listed buildings. As such the proposal is contrary to policies D1 (Design) and D2 (Heritage) of Camden's Local Development Plan 2017

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. **WHAT YOU ARE REQUIRED TO DO**


Within a period of *three months* of the Notice taking effect:

1. Totally removed the black metal and glass outbuilding from the rear garden; and
2. Make good any damage done as a result of the above works

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **22nd December 2017** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
