Hi

I am writing to ask you to reject the above planning application for the extension of the Royal Free Hospital.

I have been a resident of Belsize park for the last 15 years and am a huge fan of the Royal Freethey do phenomenal work and have treated my own family brilliantly. Given that when I first heard about their desire to extend and add additional research my first instinct was to support this.

However having learnt more I have serious concerns that this project is not thought through and will seriously damage the neighborhood if allowed to go ahead on the proposed site. In particular:

- 1) It will impact the green space by St Stephens the only green space in the heart of Belsize Park and one which provides an important touch of peace and tranquility both to residents and hospital patients and their families I do not believe this should be allowed to be impacted for any reason.
- 2) The building work risks seriously damaging St Stephens. This is a historic building and one which is enjoyed by a great many people across the neighborhood not least the children at Hampstead Hill and in my view it can not be right to embark on any building project that could damage the building without a thorough investigation and guarantees of the safety.
- 3) The building work, and end product, will inevitably bring significant extra traffic and pollution to an already very busy area impacting local residents and hospital patients and particularly the children attending the two nearby schools Hampstead Hill and Rosary Roman Catholic Primary.
- 4) The final building will significantly overlook both schools and in particular will block light and overlook the playground at Hampstead Hill nursery. Belsize Park is desperately lacking in good nursery provision and in my view we should do everything we can to ensure the children at

Hampstead Hill can continue to enjoy the outside space they have without being permanently in a shadow and overlooked.

In short I am very concerned that while I am sure the activities the Royal Free have planned are valuable, this project is ill conceived and presents significant risk to the neighboring properties and in particular St Stephens and Hampstead Hill Nursery. I believe it is crucial to do all we can to protect our children and green spaces so ask you to reject this and suggest the Royal Free consider an alternative site.

I am sure I will not be the only one to express concerns and trust you will consider this as you evaluate the proposal.


