T2 Sycamore x 1 (*Acer pseudoplatanus*) Mature, previously reduced tree. The tree is encroaching on the neighbouring property. To reduce this, the suggested works are: To prune the overhanging lateral spread back by 2 - 2.5m to the boundary line.
