In the event the Council does not support this objection, additional restrictions should be considered so that the application is not granted as proposed. In particular: 19.00-21.00 are hours when residents are likely to be home, the area has otherwise become quiet after the local shops have closed and noise is likely to be noticed. 24 events a year is far too many - assuming events won't be held when the weather is too cold this could result in an event a week or even more during the summer. In order to address both of these concerns, there should be strict limits on both the number and frequency of events. 136 persons can make significant amounts of noise - even small groups of under 10 outside local restaurants, pubs and bars can make amounts of noise disturbing to residents - large groups at roof level without other nearby structures to block the sound created will be a nuisance and there should be strict limits on numbers of attendees for any events. In addition any live or recorded music, and any equipment used for the amplification of sound, should be strictly prohibited. |      |
