We informed our neighbour Ms L Ryder approximately 1 year ago. Over this period through careful and considered instruction from her own experts and ours, she has thankfully now applied to remove the Ash Tree that has been shown to be the likely cause of the subsidence effecting the rear extension of our flat and the first floor flat directly above us. We share sadness for the loss of the tree but write to strongly support this application. We would state that we enjoy our trees and have many in our garden that we manage. The Ash tree is fully mature and healthy but through the most recent seasons, it's roots are removing more moisture from the clay soil under the foundations, causing movement. The proximity of the tree trunk is closer than the application drawing indicates from Bucks Plant Care Ltd. A bore hole test has shown that the roots track under our property. The monitoring of the cracks has shown seasonal movement that is marked and dramatic during the summer months when rainfall is low but tree root demand for water is high. Winter brings much slowing down of movement, our kitchen and conservatory have distorted so that we have had to repeatedly trim doors, adjust locks to enable us to enter our property. Internally we have had to endure distressing, unsightly cracks that are now letting in the cold air. The cracks are now approximately 2cm in width at their worst. We have all the reports and photographs available and I am available to share these with any interested party. I would like to attend any meeting that will decide how this application will proceed.
