## **DECISION**

Town and Country Planning Acts 1990 (as amended)
NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A
CONSERVATION AREA

Proposed Work:

FRONT GARDEN:

- 1 x Acer pseudoplatanus (Sycamore) Fair: Too close (2.5m) Fell and treat stump.
- 1 x Laurus nobilis (Bay) Fair: Growing into adjacent limes Reduce to 4m, trim.
- 1 x Aesculus carnea (Red Chestnut) Good: Crown reduce by 20%, raise crown by 20%, raise crown to 3m, removing only smaller branches.
- 1 x Magnolia soulangeana Fair: Overshadowed Reduce south side to balance, deadwood.
- 1 x Pittosporum tenuifolium Reduce height to 5m and trim to give the magnolia space. BACK GARDEN:
- 1 x Malus sp. (Apple) Good Crown reduce by 30%.
- 1 x Prunus sp. (Cherry) Fair Crown reduce by 30%, remove ivy from tree.

The Council has considered your notification of intended works to trees dated 26 October 2017 and does not wish to object.

- 1. This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3. Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
