following receipt of the notification of the new application from No.11 Mansion Gardens (condition 4 (a +b) of planning permission 2016/4977/P), I would like to make one comment to you both regarding the fence, as one can't comment on the application online. While I can see the practicality of re-using the boards that our neighbours at No.11 already have in situ for the new fence they plan to erect, it would be logical to try to 'match' the colour of the fence to those already in Mansion Gardens. As images of our fence, as well as the fence of No.2 were used (both in terms of the overall appearance, as well as the colour of the paint) in the application, I think it would be reasonable to hope that the replaced fence will somewhat match both of ours in colour, as opposed to the 'stain' shade shown in the images. The colour of the one in-situ right now stands out for all the wrong reasons, so I hope it is not unreasonable for me to request you to consider my comments in the overall context.
