*E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.*

Robinia pseudoacacia (T1), the tree requires an annual prune. No major reduction, just needs pruning of epicormic growth back to the knuckles (previous cuts). The reason is to protect the building and its foundations considering the tree is 13 metres high yet only 7 metres from the buildings. The pruning back of epicormic growth should stop the roots spreading towards the house and from potentially lifting the public pavement and driveways of the other residents of the building, which is only a quarter metre away. This has been an annual endeavor and if possible we would also like a rolling permission going forward.
