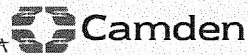

We are requesting to have the tree cut down at the request of Mr. Charles Corman of 24 Daleham Gardens as it has been

identified by their insurance company's law adjusters (report attached) as a contributing factor to the subsidence which has occurred in their flat.

We have now asked our structural engineer, Richard F. Gill & Kss. whether the work would affect our property as a result of possible 'heave' developing and were re-assured that it will not (report attached (2)).

Our insurers have also been informed and their approval obtained.
