Landscaping and tree protection details as required by conditions 4 and 5 of planning permission 2016/4441/P (dated 17/01/2017) for the erection of 2 storey rear extension; erection of 2 x dormer windows to rear roofslope; 3 x rooflights to front roofslope; and conversion of existing 16 x studio flats into 5 x 2 bedroom flats, 1 x 1 bedroom flat and 8 x studio flats.

The details submitted to discharge conditions 4 and 5 of planning permission



2016/4441/P dated 17/01/2017 are considered to be sufficient to demonstrate that the trees on site will be adequately protected during the implementation of the approved scheme in line with BS5837:2012.

The applicant has submitted details of the proposed foundations, tree protection measures and landscaping details for the front and rear gardens. The proposals include appropriate hard and soft landscaping which will be in keeping with the character of the host building and south Hampstead conservation area.

The Council's Trees and Landscaping Officer has assessed the details and confirmed they are acceptable and the conditions can be discharged.

As such, the proposed details are in general accordance with the requirements of policy CS14 and CS15 of the Local Development Framework Core Strategy, policies DP24 and DP25 of the Local Development Framework Development Policies.

2 You are advised that all conditions relating to planning permission granted on 17/01/2017 under reference 2016/4441/P which need details to be submitted, have been approved.
