Firstly many apologies for not posting my comments earlier on the tree removal case as details outlined below.

My name is Derya Kemmis and I am officially registered at 14 Rochester Road, London NW1 9JH. I have lived there since 1996.

My ex-husband, Patrick Kemmis made a tree removal application recently. Patrick also is a registered resident at 14 Rochester Road. Please kindly see details below which I extracted from Camden website.

I am writing to oppose to this tree removal application and any other future tree removal applications at 14 Rochester Road, London NW1 9JH from immediate effect. Please most kindly note my reasons below.

My reasons:

- Silver Birch Tree is a most beautiful tree and it vastly beautifies not only our house but also enhances the vision of the lovely Rochester Road and its lovely period/early Victorian/Regency surroundings.
- ∞ I lived at 14 Rochester Road since 1996 and the mature Silver Birch was already there when we moved in 1996 making this handsome tree alive for decades and more...
- ∞ I have already seen many trees removed over the years in my local area and it is only fair to stop more trees being removed unnecessarily.
- I understand this tree application been put through by my ex-husband Patrick Kemmis as some drains work needed under the garden or similar. I have not been consulted fully on these works hence don't know much of details.
