Existing balcony rester formed of steel angles with clinker block between, timber panels to the rear and a plaster/tin finish to the front. Rester formed of timber wrapped in form and felt.

48.3x5mm steel circular hollow sections welded to the top of the existing balcony rester steel at approx. 1.3m centres, with a 33.7x4mm CHS continous handrail, rolled to suit the curve of the balcony front, welded to the new posts.
