We are proposing to remove a non-structural partition wall that was erected in 1962 to create a separate self-contained flat on the ground floor of the building. The partition separates the stairs and common parts of the building from the ground floor flat. The 1962 partition was erected in a sensitive way so that the existing fabric of the house was not damaged or significantly altered.

Why is it necessary to demolish or extend (as applicable) all or part of the building(s) and or structure(s)?

It is necessary to remove this non-structural partition to reconnect the ground floor rooms with the upper part of the house and to reinstate the original layout of the house.
