Scarlet Oak T1 (15M high, 450mm dia.) - Raise canopy to 4 metres above ground level. Reduce lower 2/3rd of crown by up to 2 metres. Thin crown by 20%. Reduce co-dominant leader on house side by 1/3rd

Reason:

1. Good specimen semi-mature tree that requires formative and structural pruning for the future
2. Very low canopy over road and garage that requires raising to prevent damage
3. Typical Scarlet Oak(wide low down) crown that requires some reduction to contain within crowded the growing environment
