Thank you for your enquiry received on the 3rd of June 2009, regarding a proposed roof extension to create a first floor level at the above office premises.

Based on the information you have provided it appears that the design of the roof extension would be in keeping with the design of the existing building and due to its setback from Jamestown Road would have no adverse impact on the character or appearance of the street scene.

Other issues including the impact of the roof extension on the amenity of the adjoining occupiers in terms of bulk, loss of light and overlooking would need to be assessed once a formal application is lodged and the officer is able to conduct a site inspection.
