Proposal:

(TPO Ref: C16) WITHIN THE COURTYARD - 1 x London Plane - Reduce back 1x lowest limb from rear elevation by 3m, reduce back 1x lowest limb growing towards rear elevation of 28 - 30 Theobalds Rd to previous reduction points by 3m, remove 1x lowest limb over hanging neighbouring roof, remove stub from lowest limb over hanging the rear of No.36, and reduce 1x lowest limb over hanging the rear garden area of No.36 by 4m.

The Council has considered your application dated 27 October 2017 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

1 This decision is valid for 2 years from the date of this decision or until the work is completed, which ever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.
