PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990 (AS AMENDED)

LISTED BUILDING ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

2. THE LISTED BUILDING

Land at: Flat 3, 217 North Gower Street, London, NW1 2NR as shown outlined in black on the attached plan ("the Property").

3. THE CONTRAVENTION ALLEGED

Without listed building consent: Unauthorised installation of a single storey timber conservatory at rear roof level, together with the installation of an internal wall in the living room of the top floor flat in order to create an additional bedroom.

4. REASONS FOR ISSUING THIS NOTICE

- a) The work outlined above has been carried out to this Grade II listed building without the benefit of Listed Building Consent.
- b) The single storey timber conservatory, by reason of its design and location is considered to detract from the character and appearance of this grade II listed building and does not serve to preserve or enhance the special historic interest of the building and is thereby considered to be contrary to policies D1 (Design) and D2 (Heritage) of Camden's Local Plan 2017.



c) The installation of an internal wall to create a new bedroom is considered to detract from the original plan-from of this grade II listed building and does not serve to preserve or enhance the special historic interest of the building and is thereby contrary to policy D2 (Heritage) of Camden's Local Plan 2017.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of six (6) months of the Notice taking effect:

- 1. Totally remove the single storey timber conservatory from rear, roof level: and
- 2. Totally remove the internal wall separating the living room and additional bedroom that has been created in the top floor flat and reinstate the living room to its original state; and
- 3. Make good any damage caused as a result of the above works.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 3 November 2017 unless an appeal is made against it beforehand.

Failure to comply with a listed building enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.
