Conifer: Approximately 7.00m: Nearest building. Fell to ground level. Reasons: Proximity to building and small overcrowded garden. Tree causing nuisance to neighbours.

Gleditsia: Reduce crown by approximately 20%, thin crown density by 20%, remove dead wood and remove clematis. These actions will help increase light levels and manage the tree at reasonable dimensions for it is location whilst preserving the trees natural characteristics and aesthetic value.
