Front Garden:
Two fine mature chestnut trees are located at the front of the property. The trees are a focal point within the environs and have high aesthetic and amenity value. The tree closest to the front gate has been subject to some heavy pruning in past years whilst the tree closest to the building has a more complete and natural crown structure. At this time we only wish to apply for the following minimally invasive pruning works.
Chestnut: Located closest to the gate. Remove dead wood throughout the crown and carry out visual climbing inspection.
Chestnut: The larger of the two trees. Remove dead wood throughout crown, carry out visual climbing inspection and remove ivy. Thin crown density by approximately 20% to increase light levels and as general maintenance.
Holly: Reduce crown by approximately 30% to include raising of low branches as general maintenance and to re-shape crown which is somewhat asymmetrical.
Salix Caprice: Goat Willow. Re-pollard to previous points to prevent potential limb breakage hazard and help curtail the trees zone of influence in relation to buildings.
