ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at: Flat 60 Highstone Mansions , 84 Camden Road, London, NW1 9DY as shown outlined in black on the attached plan ("the Property").

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Unauthorised installation of 4 x uPVC windows on the front elevation

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years
- b) The replacement uPVC windows, by virtue of their frame size, proportions and detailed design, have resulted in harming the visual appearance of the host building and the character and appearance of this part of the Regent's Canal Conservation Area, and is thereby contrary to policies D1 and D2 of the London Borough of Camden Local Plan 2017.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO


Within a period of **three months** of the Notice taking effect:

- i. Totally remove the unauthorised 4 x uPVC windows from the front elevation; and reinstate the single glazed, critall steel framed windows to match the original windows, and;
- ii. Make good any damage caused as a result of the above

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **15th November 2017** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable twice to the "London Borough of Camden", as the Local Planning Authority.

WHAT HAPPENS IF YOU DO NOT APPEAL

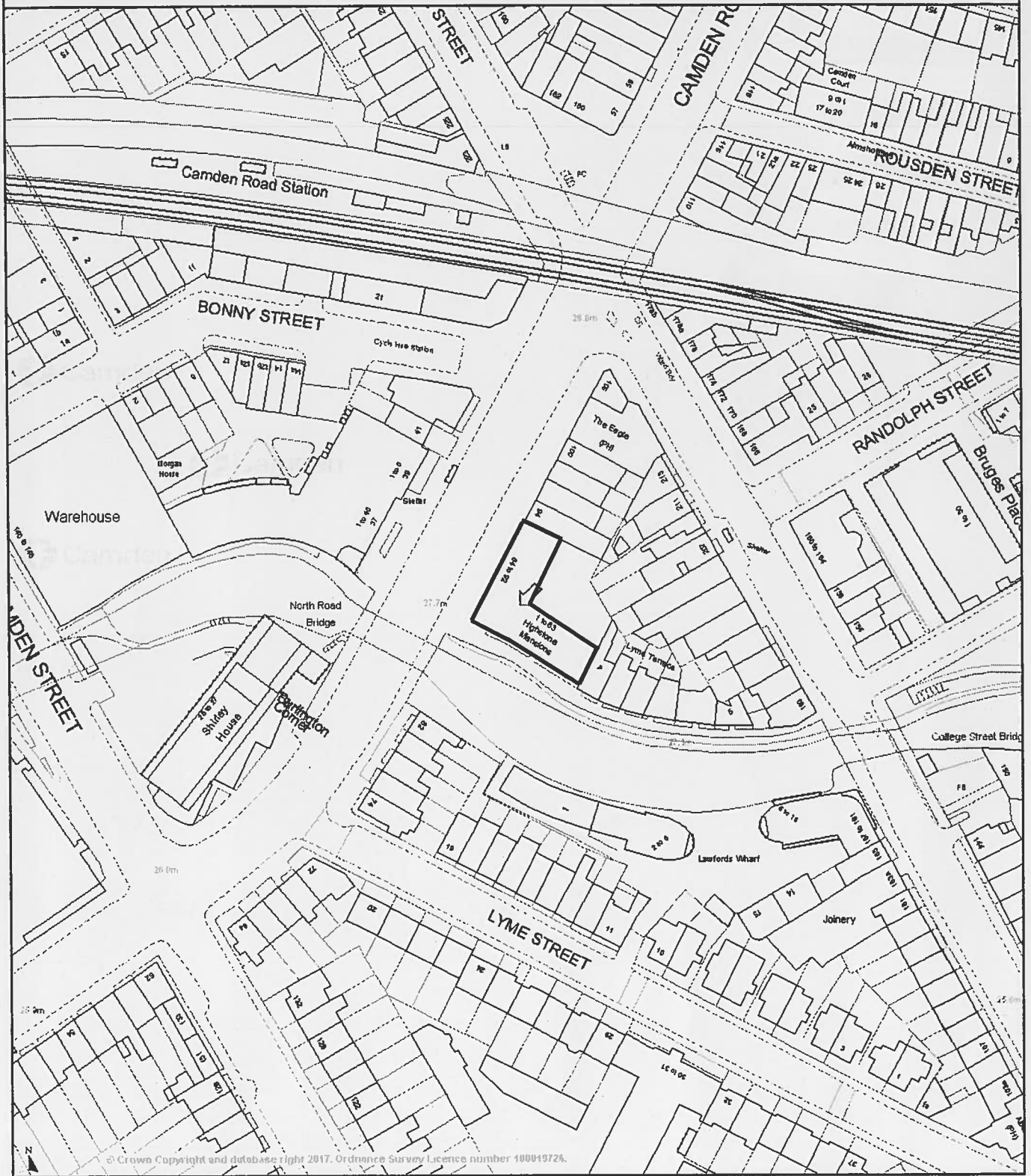
