T1 Maple - Reduce crown by 25% to control the height and spread, internal shading is a problem in the front properties. Roughly 1m to be removed from the extent of each branch to suitable points of strong growth.

T2 Yew - Overgrown hedge, reduce in height by 2m for future maintenance by tenants.

T3 Oak - Remove 2 to 2.5m from the extent of each branch to control height and spread of canopy and lessen internal shading. Tree height and width to go from 8m x 7m to 6m x 5m.
