Rear Garden:

Cherry: Approximately 4.50m. Fell to ground level. Reasons: This tree's main stem died back some years ago. The healthy remaining stem is poorly connected with an included union rendering it structurally prone to collapse in the future. Malus / Crab Apple. Approximately 7.00m. Reduce by 20-25%, thin crown density by 20%. Reasons: Toincrease light levels and help control encroachment over neighbouring property whilst preserving tree health, natural characteristics and aesthetic value.
