Cotoneaster: Reduce to approximately 2.00m in height. Reasons: This tree/shrub is now touching the roof tiles and skylights and is causing some nuisance. Removal of the main stems whilst retaining secondary growth emanating from ground level will abate nuisance whilst allowing us to retain a much smaller plant.

Elder: Located rear of flat. Approximately 5.00m and ivy clad. Fell to ground level because it has been heavily pollarded and is an extremely poor specimen.
