Rear Garden:

Pyracantha: Approximately 5.00-6.00m. This mature plant is situated near to the left hand boundary of the garden and appears in relatively good health. Remove lesser stem closest to the building, reduce growth of remaining crown back into main crown structure by approximately 20% to form a more compact and balanced crown.

Mulberry: Located in Stanley House, Yorkshire Grey Place, NW3 6UJ and overhanging 9 Church Row. Raise crown over 9 Church Row by 1.00-1.50m. Judiciously reduce overhang by approximately 30% to help control encroachment whilst preserving the trees screening effects, natural characteristics and aesthetic value.
