Rear Garden:
T1: Birch: Remove ivy to ground level.
G1: Bay Group: Reduce crowns by approximately 25%, thin crown density by 20-25% and remove dead wood throughout.
T2: Holly: Adjacent bays. Reduce crown by approximately 20%.
T3: Liquid Amber: No action.
T4: Hornbeam: Thin crown density by 20% and remove dead wood throughout crown.
T5 & T6: Cypress: Growing beneath hornbeams. Reduce crown heights by 25-30%.
T7: Cherry: Remove Ivy.
T8: Eucalyptus: Reduce crown height by 40%.
T9: Oak: Remove the ivy from the main stem.
T10: Oak: Remove dead wood throughout crown.

7. Identification Of Tree(s) And Description Of Works

T11: Plane: Reduce back to most previous reduction points whilst preserving a suitable amount of furnishing growth to ensure crown continuity, natural characteristics and aesthetic value.

Reasons: All above works are general maintenance.

T12: Hawthorn: This tree has been in decline for many years. The trees condition has significantly worsened over the last five years. Removal would be advisable. Fell to ground level.
