**ENFORCEMENT NOTICE**

**ISSUED BY: THE LONDON BOROUGH OF CAMDEN**

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.
2. **THE LAND TO WHICH THE NOTICE RELATES**  
  
**Land at: 7 Fitzroy Square, London, W1T 5HL** as shown outlined in black on the attached plan ("the Property").
3. **THE BREACH OF PLANNING CONTROL ALLEGED**  
  
**Without planning permission:** Installation of metal gate across the front entrance steps
4. **REASONS FOR ISSUING THIS NOTICE:**
  - a) The unauthorised development has occurred within the last 4 years.
  - b) The metal gates, by reason of their visual prominence and incongruous addition to the front entrance, would harm the character and appearance of the host building and wider terrace which are listed, the streetscene and the wider Fitzroy Square Conservation Area, contrary to policies CS14 (promoting high quality places and conserving heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 (securing high quality design) and DP25 (conserving Camden's heritage) of the London Borough of Camden Local

Development Framework Development Policies and Policy D1 (Design) and Policy D2 (Heritage) of the Draft Local Plan.

The Council does not consider that planning permission should be given because planning conditions could not overcome these problems

5. **WHAT YOU ARE REQUIRED TO DO**


Within a period of **one (1) month** of the Notice taking effect:

- 1) Completely remove the metal gate across the front entrance steps of the property; and
- 2) Make good any damage to the building as a result of the works.

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **18 May 2017** unless an appeal is made against it beforehand.

**Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002**

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
