Thuja Group: Adjacent bay. Reduce/lightly prune lateral and sub lateral branches as practicable. Reduce heights by approximately 1.00-1.50m as general maintenance.

Front/Side Garden:

TPO Willow: Approximately 17.00m. The willow is now drooping low over the road and has regenerated well since it's last prune. Raise crown by 3.00-4.00m. Reduce back to previous most recent reduction points whilst preserving a suitable amount of growth to ensure crown continuity and preserve and natural characteristics and aesthetic value.
