I am writing regarding the Planning Written Representations Notification letter sent to you on 27 December 2017. This letter incorrectly stated that the appeal against our refusal of planning permission at Kebony House Oak Hill Park NW3 7LP was a written representation appeal and I ask you to disregard this letter. It is in fact a householder appeal, which is a different type of appeal.

The householder appeal will be decided by an Inspector from the Planning Inspectorate on the basis of an exchange of written statements between the people who have made the appeal and the Council, followed by a site visit.

As this appeal is proceeding under the Householder Appeals Service, there is no opportunity for you to submit further comments. We will however forward copies of all representations made to us in relation to the application, before it was determined, to the Planning Inspectorate and the appellant. The Inspector appointed by the Secretary of State will consider these representations when determining the appeal.

All information provided in your representation, including your name and address, will be published. If you object to publication in this way, please contact the Planning Inspectorate directly.
