Sloped roof was leaking and infested with wasps. It was tiled with ceramic tiles, many of which were broken or slipped out of place.

The roof terrace has several layers of waterproofing and is very lightly sloped towards the front gutter. The floor is good quality planking, as was the balustrade. This has now been replaced with a trellis to make the structure appear less heavy
