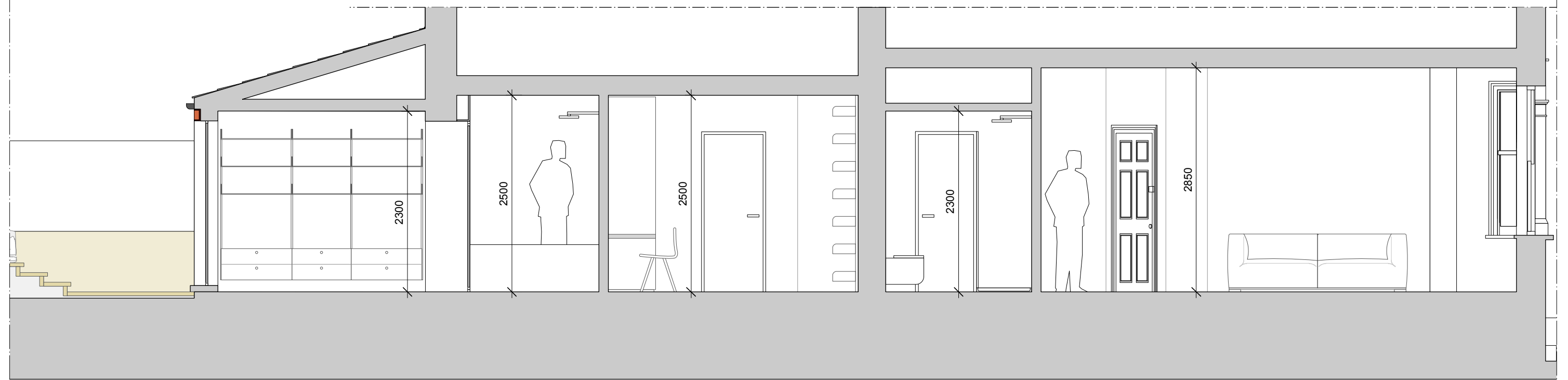

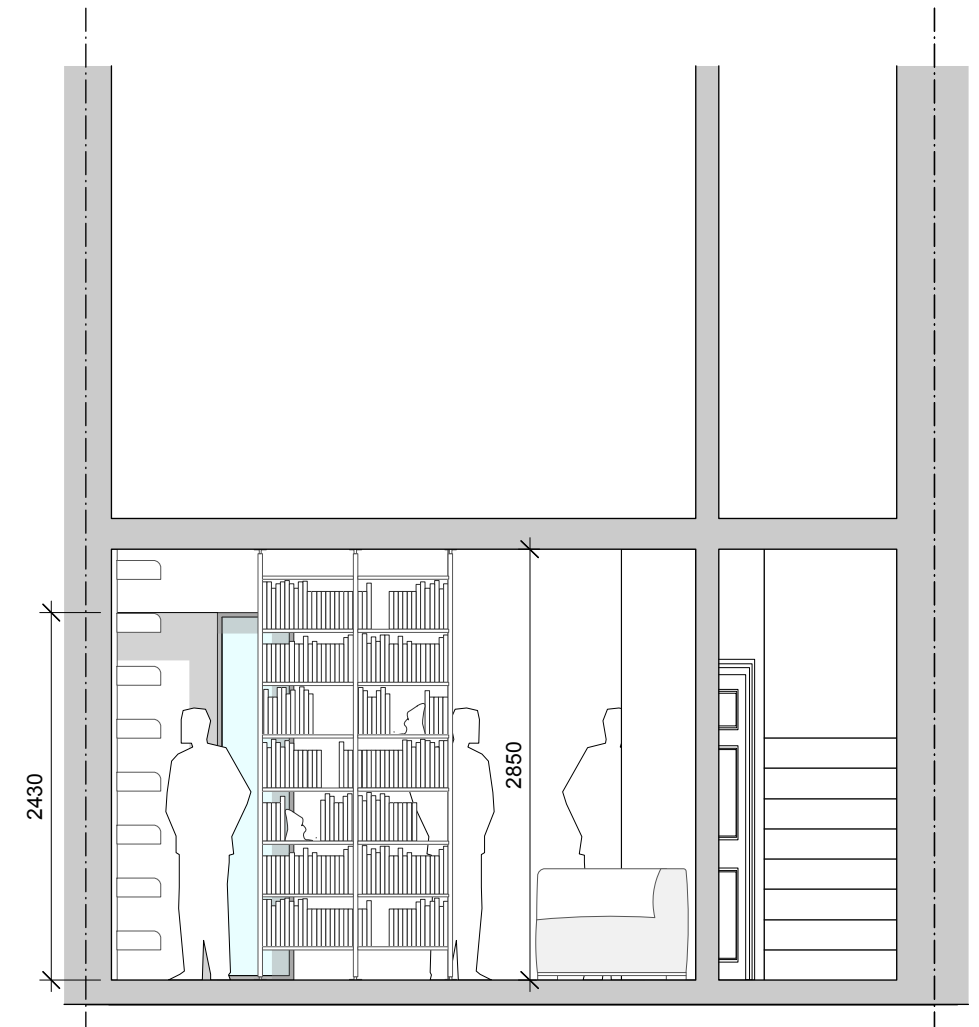

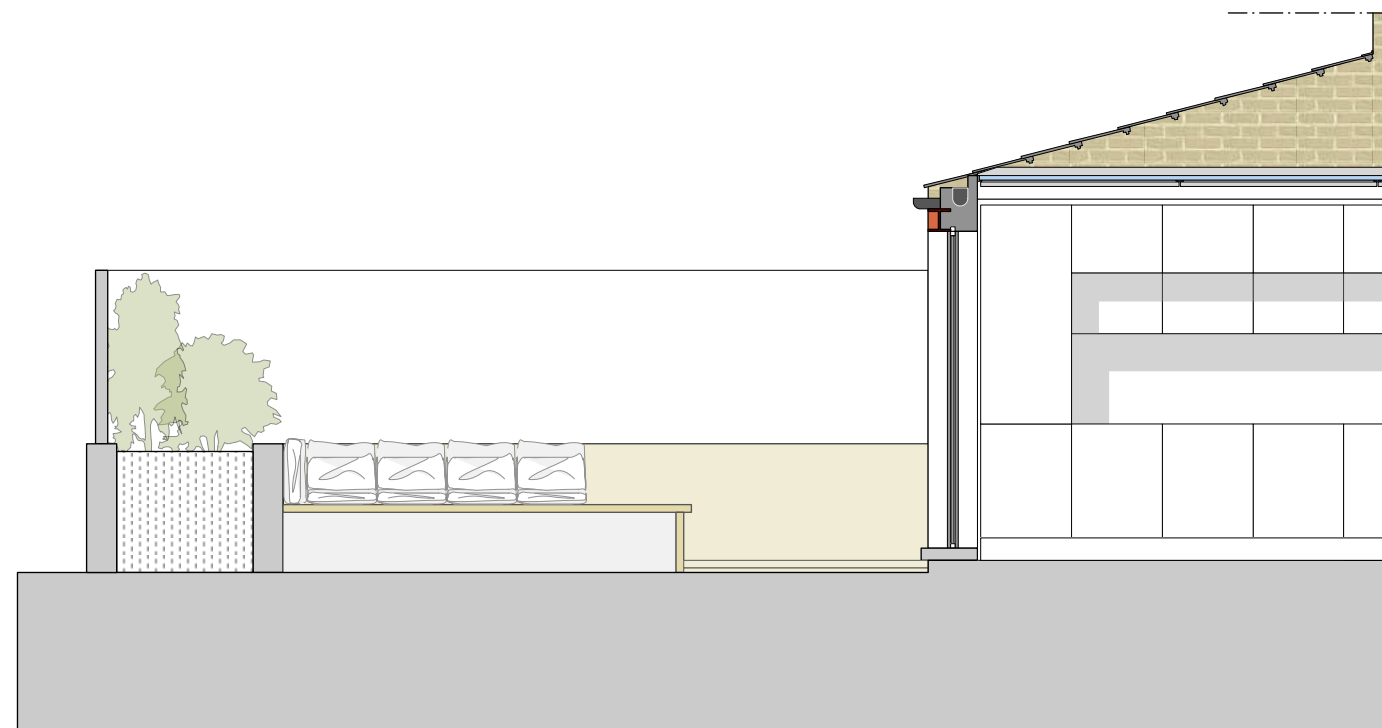
PROPOSED - REAR ELEVATION



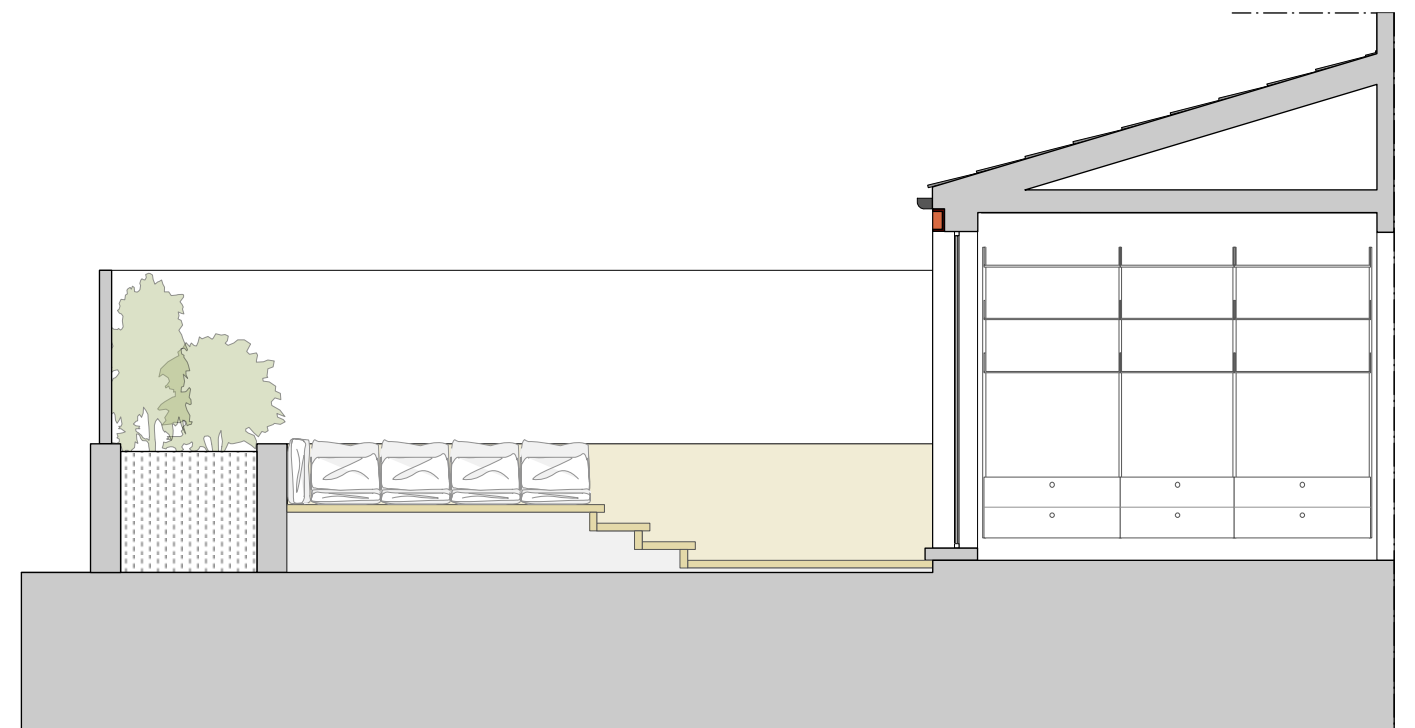

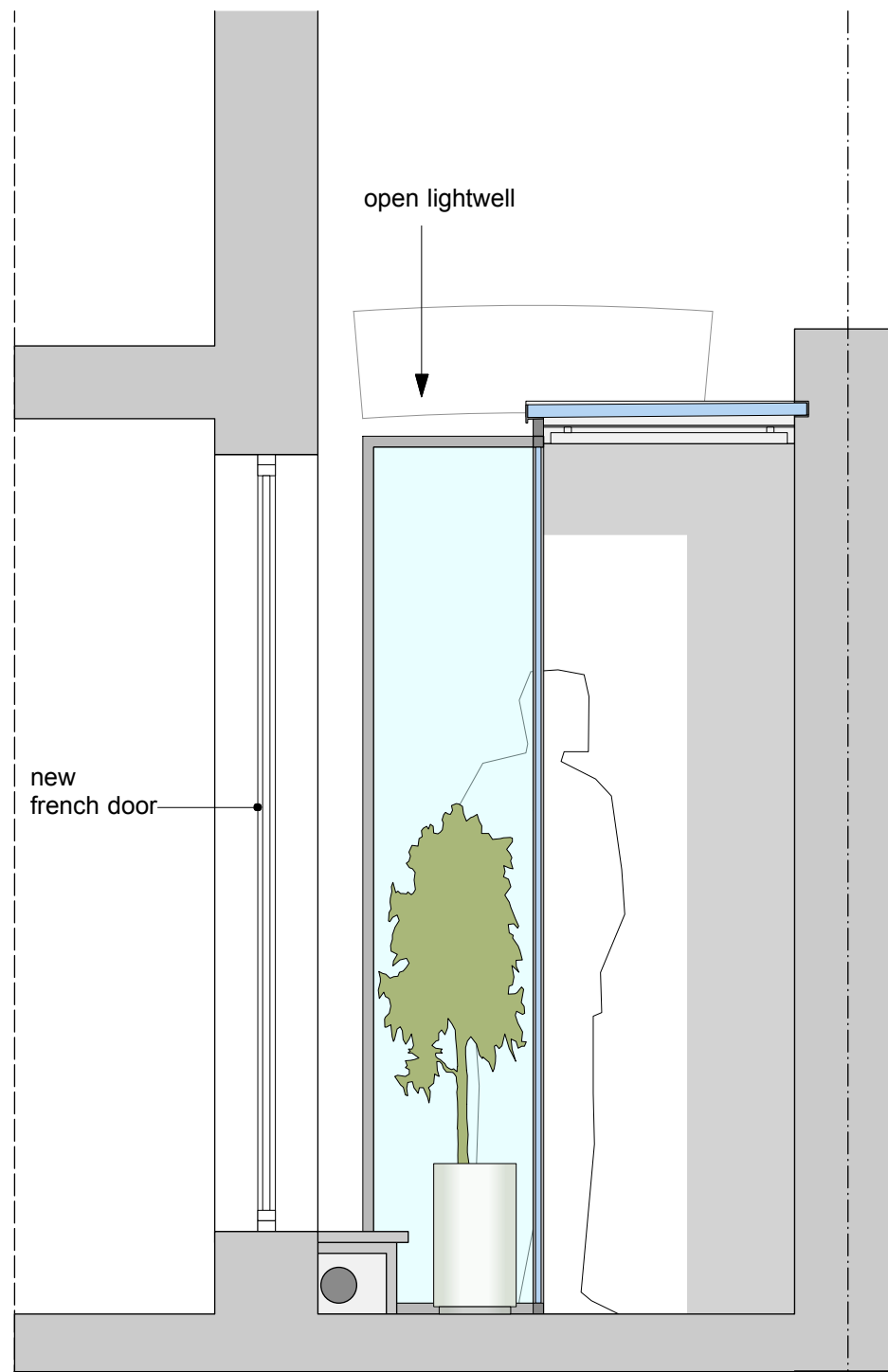

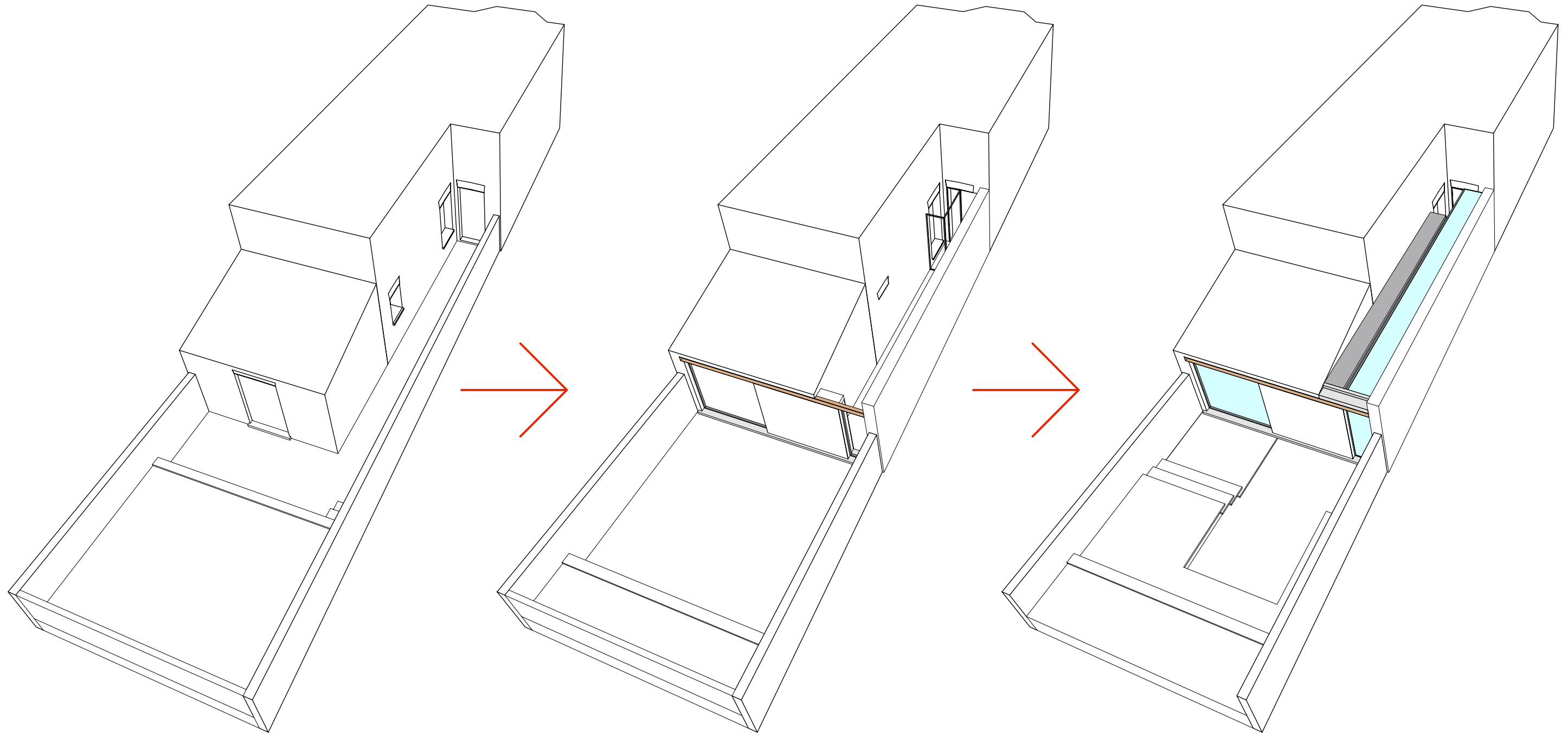
