T1 Mature, large Sycamore specimen in the rear right corner. This tree is subject to a cyclical pruning regimen to contain the crown and root area. Although generally a large broad leaf specimen would not be planted so close to a house, this tree appears to have integrated with the nearby buildings without causing heave or subsidence. Removing the specimen would pose a risk to the building, initially through expansion of the subsoil (due to the loss of significant drainage by the tree) and latterly by the space created during decomposition of the root area. It is recommended that the tree is retained, and the structurally compromised boundary wall is replaced with a fence.
