The applicant, agent and I have been in discussions about this application and its associated advertisement consent application [2017/5499/A](#) and we have negotiated the removal of the tiling to the forecourt and therefore planning permission is no longer required and I expect the agent to formally withdraw the application this week. Also, the hidden LED lighting has been removed from the proposal and replaced with 2 swan neck lights and a reduction in the size of the hanging sign with the illumination removed, as shown on the proposed drawing.

If you wish to comment on the signage application please let me know as the online form does not open for adverts as we don't formally consult.
