T3- Maple tree- Reduce two branches over garden by approximately three metres, reduce Ivy on two branches by approximately two metre.

T4- Lime tree- Remove hanging branches, dead branches and cut back to create two metres clearance from house, create two metres clearance from Cherry tree.
