- Detailed drawings, or samples of materials, as appropriate, in respect of the following shall be submitted to and approved by the Council before the relevant part of the work is begun:
  - a. all new external joinery work;
  - b. all new external metalwork;
  - c. all new external stucco mouldings including bottle balustrading.
- 3 Curtains shall be provided to the windows adjacent to the staircase and shall be drawn each night at a time that coincides with the illumination of the street lights in Regents Park Road.
- The balustrade of the proposed new internal staircase shall be constructed of glass.
- 5 The edge of the landings of the proposed new internal staircase shall be painted in a non-reflective dark colour which shall be permanently retained.
