Dear Mr Abdulali,
Regarding you and your neighbours intention to move the gate at the front of your building complex forward so it's flush with the adjoining wall, I would certainly think this would alleviate a lot of the issues you and your neighbours have been having over the past few years. In my 6.5 years working on Kentish Town Safer Neighbourhood Team I've seen events that you or anyone else would not expect to see either entering/exiting the building complex.

These have included:

People urinating in the alleyway at night (as it is set-back from the pavement and provides a secluded area).

Individuals vomiting at the location (again for the above reasons)

Individuals sat/stood at location consuming alcohol.

I've even taken a call to a female alcoholic who was seen squatting at location half naked removing her sanitary pads which were soiled and the immediate area was also covered in blood.

Youths sometimes use the area in front of the gate to smoke cigarettes/cannabis.

I definitely believe that if the gate was repositioned it would not only cut off the alleyway so this location was not a viable option for people to use but it would mean that if people were to loiter outside they would be much more visible as they would essentially be on the pavement.
