



I, Harry Disley director and authorised signatory of Angloflats Limited the owner of 25 Dennington Park Road, West Hampstead, London NW6 1BB ("the Property") **DO SOLEMNLY AND SINCERELY DECLARE** as follows:

1. On or about 7 October 1971 Angloflats Limited acquired the freehold interest in the Property which is registered under title number LN155143. A copy of the freehold title and filed plan is now produced to me and marked "Exhibit 1".
2. The Property had been converted into 4 self-contained residential two bed flats by 1979 and the Property has been laid out and used for such purposes to my knowledge since then.
3. No change of use of any part of the Property or any change to the layout of the Property has taken place since 1979.
4. The Property has, to my knowledge, been used as 4 self-contained residential two bed flats for a period in excess of 10 years, and these are separately assessed for Council Tax and have their own individual gas and electricity meters.
5. Accordingly, from my own knowledge of the Property as one of the directors and authorised signatories of the owner, Angloflats Limited, and from the documentary evidence in the exhibits annexed to this, my Statutory Declaration, I confirm that since 1979 the Property has comprised 4 self-contained residential two bed flats and there has been no change of use of the Property during that period.

And I make this solemn declaration conscientiously believing the same to be true and by virtue of the Statutory Declaration Act 1835.

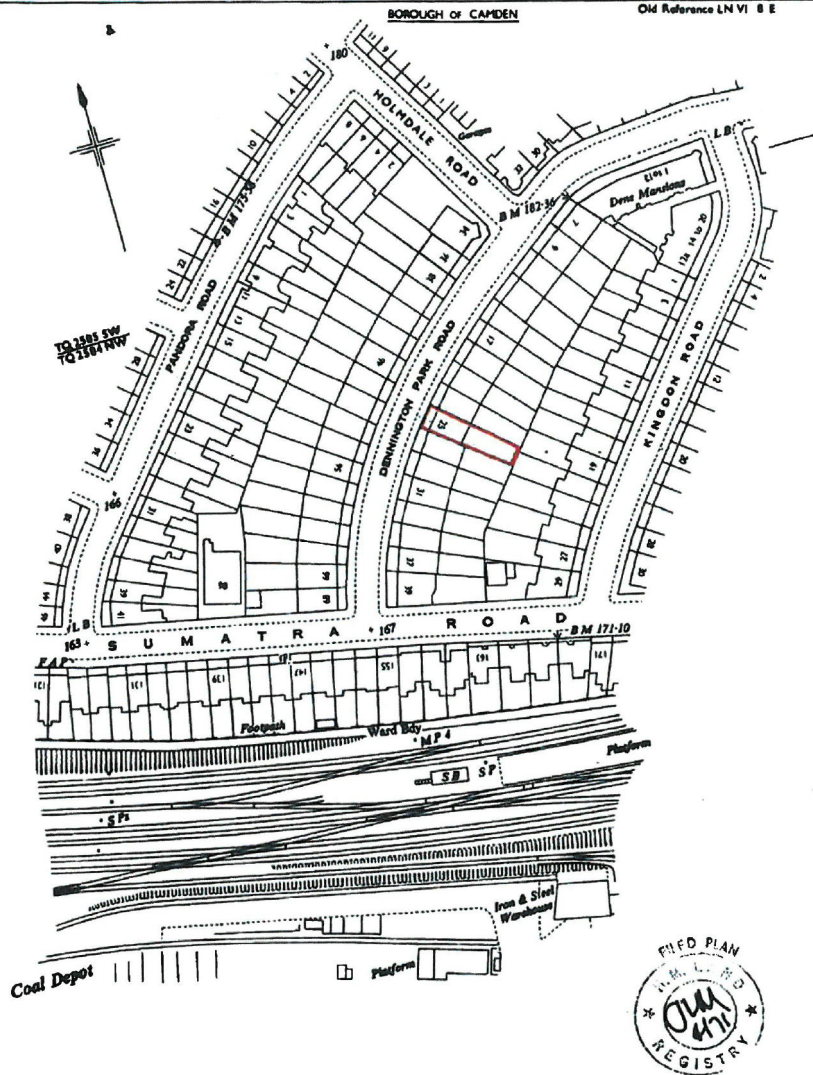

"The Purchaser for herself her successors in title and the persons deriving title under her or them owners occupiers or tenants for the time being of the property hereby conveyed or any part or parts thereof hereby covenants with the Company and its assigns that she will not permit the said property or any part thereof to be used for any trade or business whatsoever but shall keep and use the same for residential purposes only (a school for young ladies only excepted) and that nothing shall be set up used or done upon any part of the said property which shall be noxious noisy or offensive or be any interruption or annoyance to the Company its successors or assigns or to its tenants or the owners or occupiers of any adjoining or contiguous premises to the intent that this covenant shall enure for the benefit of each and every part of the adjacent or neighbouring property belonging to the Company."
- 2 The land is subject to rights of drainage through the sewers and drains thereunder.
