T3 & T4 = 2 x Medium MAGNOLIA's - NO ACTION REQUIRED

T5 = Medium PRUNUS - Crown lift to 3m and remove deadwood.

T6 = Large WEeping ASH - Reduce crown height and lateral branches by 2m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.

T7 = Large PRUNUS - Reduce crown height and lateral branches by 2m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.

T8 = Large MALUS - Reduce crown height and lateral branches by 3m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy, and remove major deadwood.
