Mr Sheehy visited the property on 28th September 2017, accompanied by our Mr J O'Neill and the Applicant, to inspect an outbuilding that had been erected without planning permission.

Mr Sheehy advised that the existing structure should be removed as soon as possible. He advised that an application for a replacement structure of similar materials but of a footprint equal to or less than 40% of the original structure might reasonably be applied for, and subject to any use being ancillary and incidental to the enjoyment of the existing residential dwelling.

The design now submitted has a footprint of 15 square metres, and as such is 36% the size of the footprint of the original structure.
