Planning Permission Ref. 2017/1867/P and its associated Listed Building Consent Ref. 2017/1868/L both granted on 23 May 2017 are in the process of implementation (nearing completion on-site). The alterations to the internal arrangement of the building reflect an earlier listed building consent Ref. 2016/0930/L granted on 15 April 2016 plus some very minor variations that resulted from design developments during the implementation of the consent (detailed in the accompanying Application Cover Letter and Heritage Impact Assessment).

The most straight forward method of achieving a consolidated permission to vary the latest planning permission via S73 to amend the approved drawings listed under Condition 3, and in parallel to submit a new application for a fresh listed building consent to reflect the totality of the amalgamation of the separate approvals plus the minor variations during the course of construction.
