1 x Ash Tree  
Reduce crown of southern, heavily cantilevered stem by 35% (shorten branch tips by 3m)  
Reduce remaining crown by 25% (shorten branch tips max 2.5m)

Reasons

Lessen the weight of the the cantilevered branch and therefore reduce the the risk of structural failure .This branch has already been braced and the fear is that the extra weight of the leaves and keys will ultimately lead to the structural failure of the branch. The reduction of the remaining crown is to balance the crown and further reduce sail area the wind can exert pressure on.

Prudent, periodic management of large tree close to houses.
