The clearstory windows overlook the roof of the host building and the proposed enlargement would not impact on occupiers' amenity in terms of loss of privacy. Similarly, the proposed rooflight would not harm occupiers' amenity due to its setting and height. The proposed works would comply with policies and CPG guidelines. It is considered that the proposed alterations would not harm the building appearance or impact on the character or the appearance of the conservation area. There are no objections in principle to the proposed alterations subject to the detailed design.
