20 GREAT QUEEN STREET PROPOSED CONDITIONS

- 1. The sale by retail of alcohol in the restaurant shall be ancillary to substantial food being available at the premises except in the area **shaded** in **blue** on the **plan**, by up to a maximum of 25 customers at any one time.
- 2. Orders for alcoholic beverages shall be taken and dispensed by waiter or waitress service only save for any holding bar area.
- 3. No alcoholic beverages shall be taken outside the premises by customers at any time unless the customer is within a lawful outside area covered by a Tables and Chairs permission (where required).
- 4. Means of escape shall be maintained unobstructed, immediately available and clearly identifiable.
- 5. Exit doors shall be checked before opening each day to ensure they function satisfactorily.
- 6. Customers smoking on the public footway shall not be permitted to cause obstruction of the highway to passersby.
- 7. Notices shall be prominently displayed at each exit from the premises asking patrons to be considerate to neighbors when leaving.
- 8. At least one member of staff on duty whilst this licence is being used shall be trained in the requirements of the Licensing Act 2003 in terms of the licensing objectives, offences committed under the Act and conditions of the Premises Licence. Such person shall be competent to ensure offences are not committed and that the premises shall be run in accordance with the licence.
- 9. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Camden Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping.
- 10. The CCTV camera views are not to be obstructed.
- 11. Copies shall be made available so far as possible within 48 hours to the Police or Local Authority, upon request.
- 12. The Venue shall not engage the services of street promoters to encourage clientele to attend the venue
- 13. At least one member of staff on duty whilst this licence is being used shall be trained in the requirements of the Licensing Act 2003 in terms of the licensing objectives, offences committed under the Act and conditions of the Premises

Licence. Such person shall be competent to ensure offences are not committed and that the premises shall be run in accordance with the licence.

14. A 'Challenge 25' policy will be enforced, where any person reasonable looking under the age of 25 shall be asked to provide their age when attempting to purchase alcohol; signs to this effect with be displayed at the premises. The only acceptable forms of identification will be photographic identification documents recognised in the Home Office guidance which includes:

A valid passport.

A valid photo card driving licence.

Proof of age card bearing a PASS hologram.

Or HM Forces may be acceptable as proof of age.

- 15. Sales of alcohol for consumption off the premises shall only be supplied with, and ancillary to a take-away meal.
- 16. No person carrying visibly open or sealed vessels of alcohol are permitted in the venue at any time that the premises are open for any licensable activity.
- 17. At least one member of staff who holds a personal licence must be on duty whilst the premises is open to the public for licensable activities.
- 18. Police must be called to all incidents of violence and disorder.
- 19. An incident log shall be kept at the premises and be made available upon request to the Police or the Local Authority. The book will record the date, time and whom is making the entry. The following must be recorded:
 - All crimes reported to the venue.
 - Lost property.
 - Any incidents of violence or serious disorder.
 - Any faults in the CCTV system.
 - Refusals of alcohol sales, including any underage attempts.
- 20. The licensee will ensure that staff are trained, as appropriate, in respect of relevant Licensing Law and upon the sale of alcohol to drunks and to persons underage.
- 21. Whilst the venue is open for licensable activities, staff will monitor the areas where customers have access; to ensure personal items are not being left unattended in the venue.
